

Time is Running Out

Special Program Proposals for 2019 must be received by November 1, 2017

Any new Special Program to be introduced for review and approval by the National Executive Council at the January meeting in 2018 needs to be received from the club that is presenting the Special Program. The program to be proposed would start on January 1, 2019. Any club considering a Special Program must have all the documentation sent to your Regional Director and to the Special Program Chair no later than November 1, 2017. The documentation should include a colored copy of the patch and its dimensions, the booklet with the program rules , etc; an expense report with a minimal order of 100 patches for cost estimation, and the original signed agreement page which includes the alternate Special Program POC signature and date. All information and regulations on hosting a Special Program are on the AVA website under AVA Policy 4.05. If you will be doing an occasional bike event during the year, then its ok to use your regular distance book. However, if you are participating in several biking events throughout the year, please purchase the brown bike book and record you bike events in this book.

Notify the AVA—When Sanctioning Events Less Than 90 Days.

To hold traditional events, it's preferable that events are sanctioned at least 90 days prior to the event date. This time allows us to prepare and mail out stamps in a timely manner. It also allows us time to get your event in the TAW. If the event is in less than 90 days and it has been approved by your Regional Director, please have them notify Samanta by email at samanta@ava.org or call the ava office as soon as possible. AVA Photo Disclosure

The following photo disclosure has been and added to the Youth Waiver Release form and AVA start cards and posted on the AVA website Facebook page:

Members, please be aware that when you share any photos, via digital image or otherwise, with AVA, such photos or images become the property of AVA and AVA, its legal representatives and assigns, retain the right and permission to publish, any such photo or image in any written or electronic publication, including Checkpoint or TAW, on social media, websites, or in audio-visual presentations, promotional literature, advertising or in other similar ways.

While it is not the intent of the AVA to share or reproduce any photos without consent of the individuals in the photos the disclosure gives the AVA and its club's permission to use photos taken at any AVA public event for promotional purposes.

AVA Release of Liability for Minor Participants

The Release of Liability form for minor participants under the age of 18 has been updated and is on the AVA website under the Events/Youth Programs tab. This form must be completed and signed by a parent or guardian before they participate in any of our events. The signed form should be kept in the club's file for 7 years.

Although the AVA photo disclosure is included in the Release of Liability Form, the AVA will not publish or reproduce any photos of youth without the express written consent of the parent or guardian. Any photos used will be for promotional purposes only. Per guidance from our legal counsel and insurance broker, the AVA recommends that clubs do not use photos of youth in any promotional or advertising literature or post pictures of youth on social media.

AVA Legal Counsel

One of the areas the National Office supports clubs with is legal counsel. The AVA does have an attorney who represents us on an on-call basis as needed. We are very fortunate she does not charge us an annual retainer and she also gives us a discounted nonprofit rate! If a situation arises whereby you think your club might need the guidance of our attorney please advise your Regional Director and they will make sure it gets addressed by our legal counsel. If it is something urgent please contact the Executive Director asap at henry@ava.org

Please do not ever sign any legal documents on behalf of the AVA or share any club files or other confidential information with a third party even if subpoenaed without consulting our legal counsel first. If you are uncertain, it is always best to advise your Regional Director first before taking any action.

New Programs on the Horizon!

Last January a new classification of AVA events was introduced to the NEC. These events called "Community Events" were approved by the NEC in August. The Community Events fall into three categories, **Youth Community Events**, **Traditional Community Events**, **and Guided Community Events**. The criteria for hosting these types of events will be published in the November Checkpoint. The projected start date for these events is January 2018. The NEC also approved the **401K**: **Invest in Your Health Program**. This program is an internet based program that utilizes the Walker Tracker application. The online application will allow AVA club member participants to log on and track their kilometers, steps, walk history, photos, and other cool features for walking activities. The cost to enroll in the program is \$18.00 per participant. Look for payment and enrollment instructions on the AVA website in November. The projected start date is January 2018.
