Introduction of Nominating Committee Chair Chris Mellen:

No proposals were received to host a 2025 Convention. Thinking more broadly, a suggestion was made to host a convention in conjunction with a cruise. Details are being worked.

Request for Comments from Delegates:

- John McClellan (AVA-0717) had comments on the Executive Director's Report:
 - With respect to the Olympiad, all volunteers should be formally and officially recognized and thanked. In particular, several members put in hundreds of hours before and during the event.
 - Concerning members listed in the Biennial Report as sustaining donors, have those 14 individual donors been formally thanked or recognized?
- John McClellan (AVA -0717) asked if the US FreedomWalk Festival Club (USFWF), under leadership of Dolores Grenier, would make a formal bid for the 2025 Convention. Convention Chair Jerry Wilson replied that since AVA received no bids, the cruise proposal was in lieu of a formal bid, and Dolores Grenier stated the USFWF Club would not be in charge of the effort. Jerry Wilson suggested that perhaps future conventions could be similar to the Olympiad model, in which local clubs provide structure, but there is help from all regions.
- Mary Frink (AVA-0269) asked how an Americaspiad would work with Convention? The Piads tend to affiliate with the International Marching League, so there would need to be at least 20-km routes offered each day, but Convention business could still be part of the event.
