LIFETIME MEMBERSHIP SUNSETTING MARCH 31, 2025

GROUPER STRIDER AND RSVP PROGRAMS UPDATE

Grouper Strider Program Discontinued

The Strider program was a walk referral participation program sponsored by our partner, Grouper. The walk fees for these participants were paid by Grouper and the AVA reimbursed clubs \$2.00 for these participants. This program has been discontinued effective January 2, 2025. **Strider participants must now pay for all fees to include walks, awards, park fees, and special events fees.**

Grouper RSVP Program

When a club gets an RSVP email from Grouper advising them a participant will attend one of their events, it is because the participant in question has used the Grouper RSVP program that allows the walker to select an AVA event via the Grouper online interface. This participant is called a Grouper RSVP walker.

Clubs do not report RSVP participation for self-guided walks because that report is generated by Grouper and reported separately to the AVA. Grouper reimburses the AVA \$1.00 for all RVSP participants who have registered in their portal whether they actually attend a self-guided walk. The AVA credits the \$1.00 to clubs at the end of the 1st Quarter of the following year. Clubs do not need to do anything to receive this credit.

Grouper also reimburses clubs \$1.75 for all RSVP participants who attend group activities to include group walks, traditional walks, and club socials. **However, for clubs to receive the \$1.75 reimbursement, they must be registered in the Grouper portal and confirm the RSVP participation.** If clubs do not do this, they will receive a \$1.00 reimbursement instead of \$1.75. Grouper tracks these numbers and reports them to the AVA at the end of the year with payment. The AVA credits these fees to clubs on an annual basis. Fees for a given year are credited to the club's Quarter 1 participation invoice for the following year.

Joining the Grouper network is not required for clubs to benefit from this program. However, we highly encourage clubs to join the Grouper network so clubs can maximize the benefits and communicate effectively with RSVP participants. VOLUNTEERS NEEDED FOR TELLERS AND CREDENTIALING

The AVA Secretary is looking for volunteers to serve as Tellers and in Credentialing.

What are tellers you ask? Tellers will assist in vote counting during the AVA's Biennial Convention in Las Cruces. Tellers would need to be available during the business meetings.

What is Credentialing? Credentialing is the process of confirming the delegates, alternates, and proxies, representing each club at the convention and providing them with their credentials to be able to vote in the business meetings. Credentialing also determines if a quorum has been met. Credentialing takes place at various times, such as during convention registration and immediately prior to business meetings. Voting delegates and alternates cannot be Tellers.

Both these positions are necessary for conducting business at the AVA Biennial Convention. Tellers and Credentialing work with the AVA Secretary to assure everyone who should vote votes and that the votes are counted accurately.

MULTI-DAY EVENTS (FESTS)

Many fellow walkers use the Multi-Day Events Calendar to plan their vacations/walking trips. The earlier a club can enter information about their upcoming fests the greater the lead time to prospective attendees for planning travel dates, transportation, accommodations and daily schedules.

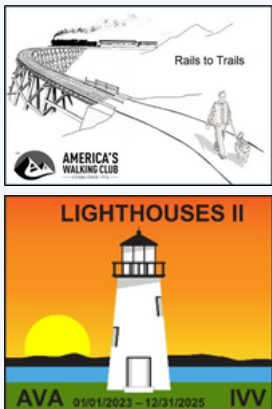
To create a new Fest or edit an existing one, you must be logged into my.ava.org and have club management privileges. The IT Committee has developed an online data entry form for you to use when creating your club’s fest. The first 5 data fields are required when creating the fest entry: start date, end date, name of the fest, city or town where the fest will take place, and the 2-character state abbreviation. The remaining data fields (registration location, POC name and email, and website) can be entered later. If you have an approved save-the-date flyer or brochure, you can upload it at this time or later. The next step is to enter the sanction numbers of the events if known at the time. Any of the non-required data fields can be entered later by editing the fest. And finally, be sure and click on the “Save” button!

During the entire data entry or edit process, there is a “Help” function available to assist you with the necessary steps. If you have any questions during the process, please do not hesitate to contact your Regional Director or programs@ava.org for assistance. So please take advantage of adding your fests to the Multi-Day Event Calendar to promote your events to both local walkers as well as travelers interested in seeing new areas of our country!

THE SEARCH IS ON! SPECIAL PROGRAMS NEEDED FOR 2027

Does your club have an idea for a new AVA Special Program they would like to sponsor beginning in 2027? Three current Special Programs (Lighthouses II, Par For the Course, and Rails-to-Trails) will end on 12/31/26, so the Programs Committee will be looking for three new Special Programs to begin on January 1, 2027.

Do you know of a theme that would generate interest from a historical, cultural, educational, or scenic beauty perspective that has not previously been a Special Program? Are there major or intriguing American anniversaries occurring in 2027? Now would be the time to put your creative ideas and imagination to work. Talk with club members on walks as some have additional interests outside walking (yes, it does happen) and those other activities may generate ideas. Check your community calendars for local celebrations that are applicable across all states. Add “Brainstorming Special Programs” to the club’s meeting agenda and solicit ideas at the meetings.

The AVA Special Program Policy limits new Programs Committee recommendations to just one AVA Board of Directors (BOD) meeting per year, which is typically the first meeting of the calendar year (i.e. 2026). The Special Program begins January 1st of the following year (i.e. 2027). Committee recommendations at the first BOD meeting of the calendar year provides sufficient time in the remaining year for the sponsoring club to submit articles to TAW and the Checkpoint describing the new program, obtain booklets/awards, and create program information for the AVA webpage and OSB. Plus, it allows the clubs across the country to understand the details of the new Special Program, review/modify their current YRE/Seasonal trails, or develop new routes or traditional events to include the qualifiers of the new program.

PROPER ATTRIBUTION FOR EVENT DIRECTION MAPS

This article is meant to remind clubs that AVA Policy, <https://my.ava.org/files/tutorials/AVA-Policy-Event-Directions.pdf> requires copyrighted materials in event directions to comply with the usage rules for the copyrighted material.

Event directions should contain maps where the walking/biking route has been added. These maps are typically created using plotaroute.com or perhaps a map downloaded from a website.

The plotaroute.com service creates maps based on map data from OpenStreetMap, the maps created/displayed using plotaroute.com have the appropriate attribution in the lower left-hand corner:



The blue highlighted text is actually a link, <https://www.openstreetmap.org/copyright>, leading to a page that describes the preferred attribution. This page is a link to the OpenStreetMap Attribution Guidelines page, https://osmfoundation.org/wiki/Licence/Attribution_Guidelines.

The Attribution Guidelines page contains the following section that is applicable to PDF files:

“Books, magazines, and printed maps”

For a printed map and similar media (that is ebooks, PDFs and so on), the credit must appear beside the map if that is where other such credits appear, or in a footnote/endnote if that is where other credits appear, or in the “acknowledgements” section of the publication (often at the start of a book or magazine) if that is where other credits appear. The URL to [openstreetmap.org/copyright](https://www.openstreetmap.org/copyright) must be printed out.”

When clubs create event direction maps using plotaroute.com, they often crop the map images with result of cutting off this attribution. This attribution should be restored to the map by either pasting the image of the original attribution or adding a text box like:

Map Data Copyright [OpenStreetMap Contributors](https://www.openstreetmap.org/contributors)

to the map image. Note the link in the above box leads to <https://www.openstreetmap.org/copyright>.

For maps that are downloaded from, for example, a park website that is then modified to display the walking/biking route and there are no obvious copyright or attribution guidelines, then the maps should include a link to the page where the map was downloaded from. For example,

Map: [Pennypack Map 072216](#)

Finally, a number of OSB event directions have been approved even though they did not contain the proper attribution for their maps. Starting in 2025 new OSB directions files will be required to contain the proper attribution for the maps they contain. Also Regional and Deputy Regional Directors need to check that updated OSB direction file maps contain the proper attribution prior to approval.
